AN OVERVIEW



**Kelulusan Untuk Menjalankan Perniagaan Pembrokeran Insurans
dan Perniagaan Pembrokeran Takaful**

Permohonan untuk kelulusan bagi menjalankan perniagaan pembrokeran insurans dan perniagaan pembrokeran takaful oleh PROTAC Insurance Brokers Sdn. Bhd. (PROTAC) adalah dirujuk.

2. Bank Negara Malaysia (BNM) **meluluskan** permohonan PROTAC untuk menjalankan perniagaan pembrokeran insurans dan perniagaan pembrokeran takaful bagi tempoh **dua tahun** bermula **1 Jun 2025** **hingga 31 Mei 2027**, menurut **seksyen 11(2)(a)** Akta Perkhidmatan Kewangan 2013 (APK) dibaca bersama seksyen **15(1)(b)** APK, dengan syarat-syarat berikut:

- i. PROTAC hendaklah mengemukakan salinan polisi insurans indemniti professional (professional indemnity insurance) dalam tempoh **dua (2) minggu** setiap kali selepas polisi diperbaharui; dan
- ii. PROTAC hendaklah mengemukakan akaun yang telah diaudit bagi setiap tahun kewangan sepanjang tempoh kelulusan dalam tempoh **tiga (3) bulan** dari tarikh tutup tahun kewangan syarikat.

Kegagalan untuk mematuhi syarat yang dikenakan terhadap kelulusan yang diberikan juga merupakan suatu kesalahan jenayah di bawah seksyen 13(2) APK.

3. Untuk makluman tuan, BNM boleh membatalkan kelulusan yang diberikan kepada PROTAC menurut seksyen 20 APK termasuklah dalam keadaan-keadaan berikut:

- i. sekiranya PROTAC melakukan sebarang kesalahan yang berulang, di mana kesalahan tersebut telah dibangkitkan dalam surat kelulusan yang dikeluarkan oleh BNM sebelum ini;
- ii. sekiranya PROTAC gagal untuk mematuhi sebarang syarat yang dikenakan ke atasnya (termasuk syarat-syarat yang dinyatakan di perenggan 2); atau
- iii. sekiranya PROTAC memungkir atau melanggar mana-mana peruntukan APK atau Akta Perkhidmatan Kewangan Islam 2013 (APKI).

4. BNM juga ingin menekankan obligasi PROTAC untuk sentiasa mematuhi kehendak di bawah seksyen 125 APK dan seksyen 137 APKI, termasuk memastikan segala wang yang diterima berkaitan dengan suatu kontrak insurans / takaful atau suatu kontrak insurans / takaful yang dicadangkan diselenggara dalam suatu akaun bank berlesen atau bank Islam berlesen yang berasingan daripada akaunnya sendiri.
